- 1. <u>REGISTRATION FORM</u> —This form is renewed every year. Student must register for the FVF and provide us with the most updated information.
- 2. <u>HLPUSD RELEASE FORM</u>—While FVF benefits Workman Students and has an office on campus, we are not supervised or sponsored by HLPUSD. Guardian and child must sign this form. This form is valid for all 4 years.
- 3. <u>LIABILITY RELEASE FORM</u>— Because FVF is its own entity, we require for parents & students to release liability to HLPUSD, Workman, and FVF Associates. This form is valid for all 4 years.
- 4. <u>ACADEMIC RELEASE FORM</u>—We require your consent to access your child's academic and attendance records. While there is no GPA requirement to join our program, we expect our members to upkeep their grades and we may need this information for events such as College Tours. This form is valid for all 4 years.
- 5. <u>CODE OF CONDUCT</u> —We require positive values and expect Venturers to set standards and examples. Your child's conduct is ALWAYS expected to be excellent. By signing this form, the student understands and agrees to follow the Code of Conduct at all times. This form is renewed every year.
- 6. <u>BOY SCOUT MEDICAL PACKET</u> (Part A, B, and C) We require medical information and authorization to help & provide assistance to students and adults during our trips. Part A & B are for the Fall Semester. Part C (Physical) is for the Spring Semester. If a student has already completed a physical, they can use the same one for us. This form needs to be renewed every year.
- 7. <u>BOY SCOUT REGISTRATION FORM</u>—FVF is a chartered organization of the BSA (Boy Scouts of America). We run our Venture Crew in accordance with our own policies as well as those of the BSA. **Applicants over 18 years of age must fill out the Adult Scout Form.** This form is valid for all 4 years.

Adult Volunteers must fill out separate paperwork, please see Felix Ventures Office or <u>felixventures.org</u>. We welcome all adults to attend our monthly Association Meetings.
